

## Canterbury Farmers Market Guidelines

***Who may sell at the market?*** Only vendors who have submitted a completed application and have been approved by the farmer's market committee can sell at the market.

***What can be sold?*** Items that may be sold at the market includes locally grown fruits, vegetables and meats, baked goods, prepared foods and hand crafted items. Items must be pre-approved by the farmer's market committee. All fruits and vegetables sold must be grown by the farmer. All prices must be clear and visible.

***Becoming a vendor:*** Vendors are required to submit an application to the Farmers Market Committee that includes a description of the products sold. Additional information may include

- CT Sales Tax Permit
- Health Department Permit
- Photos of Products to be sold- artisans only
- Certificate of product liability insurance

Vendors will also be required to provide proof of a minimum \$300,000 liability insurance.

***Hours of Operation:*** The market will run on Tuesdays from 4:00-6:30 PM. Setup will begin at 3:00 PM. All vendors must be in place and ready for sale at 4:00. There will be no selling before 4:00 or after 6:30.

***Vendor Space:*** Vendors will be given a space of approximately 10'x10' which will be assigned by the Market Master. Sites will be assigned for the season once a completed application is received. Sites will remain fixed for the duration of the season. Vendors must leave the site in the same condition as upon arrival. All vendors must have a sign properly identifying their business.

***Vendor Attendance:*** Full time vendors are expected to maintain weekly attendance. In case of emergencies or unexpected absence, the vendor must contact the Market Master directly.

***The Canterbury Farmers Market Committee reserves the right to amend these rules as needed***
