MINUTES

I. **Call to Order**

T. Brummett called the meeting to order at 7:07 p.m.

II. **Roll Call**

III. **Minutes- October 25, 2017**

K. DeCarli made a motion to approve the minutes as amended. N. Geragotelis seconded the motion and it passed unanimously.

IV. **Old Business**

A. **IWC Application #17-9-GRAVEL, Adelman Family, LLC, Earth Excavation, Butts Bridge Road & Camp Road, Assessor's Map 60, Lots 42, 43, 45, 46, 48.**

D. Held was not present at the meeting. Several members walked the property. K. DeCarli questioned the final grade of 117 in phase

B. **Timber Harvest, Racy, 395 Water Street**

This harvest has been completed. E. Hansen submitted photographs of the dirt road after the operation was complete to the office. Due to scheduling conflicts the property was not viewed prior to the harvest. M. Gil stated that she did go to the property after it had been completed and everything looked fine. T. Brummett expressed concern that the forester completed the harvest prior to the Commission or the Wetlands Enforcement Officer viewing the property.

C. **Timber Harvest, Marada, LLC, South Canterbury Road**

Several members walked the Marada property. Buster Land Management would be a temporary bridged stream crossing. The members discussed the slope of the property, and expressed concern with skid trail going through the field. They recommended that the harvest be completed during the dry season and that the office is notified when the operation begins. M. Gil will contact B. Cutler.

V. **New Business**

A. **Timber Harvest, Dailey, 314 Barstow Road**

D. DuBois was present at the meeting to discuss the harvest with the Commission. He would be harvesting the Dailey property at 314 Barstow Road. He stated that approximately 312,000 feet/550 cords of forest projects will be removed. He noted that the property suffered significantly due to the gypsy moths. D. DuBois stated that the landing area will be located on Barstow Road and a tracking pad will be installed. An

existing wood road system will be utilized. Upon completion of the operation the trails and roads would be seeded with a conservation grass mixture. He stated that the operation would take approximately two months to complete unless work gets stopped in the process. D. DuBois stated he would notify the office when he began.
